The Second Annual Meeting of the Point Grey Community Centre was held on Feb. 13th at the Lawn Bowling Club Elm & 43rd at 8 P.M.

Mr. Macdonald, President, welcomed members and thanked them for their attending.

Secretary report. adopted, 2nd Mr. Cameron.
Treasurers report, Mr. Barnes Balance of cash

Mr. Macdonald expressed our regret at the loss of one of our Board Members Mr. Bert Hoy, and the Secretary was instructed to write a letter of sympathy to Mrs. Hoy.

Mr. Macdonald gave a description of the plan to erect a rink ax ice 90 ft by 190 regulation hockey at a cost of \$135.00, this costs about \$13,0 00.00 a year to run a rink and the profits could be used to put up a curling and fancy skating rink, if sufficient money were not raised to put up the whole community centre at once.

Mr. Adams, asked what schemes had been krive proposed to raise money.

Mr. Macdonald replied that the plan had been to go out and get it by public subscription, to put on a campaign under a qualified campaign mamager,

Mr. Cameron replied as to the status of the property and that the \$135,000.00 was for the Building only not the land. and tonight we must decid e should we go ahead and raise the money.

Mr. Lambke, asked if we were surexwaxxxx the scheme would not peter out.

Mr. Harrison felt we were stressing a skating rink only, and that a Place for Dancing wax for the younger ones was just as necessary and important as a Rink., and what would the rink be used for in summer time.

Mr. Macdonald replied that if the project was completed thate was not much chance of it pettering out as there were so many young people in the district, and that in summer it would be converted into a Roller Rink.

Major Whitley said that he feels "If we are worthy of the trust of the children, something would be done, that people were prone to look to the Government elected officials to do things for them, but here is a chance for us to do something for ourselves.

Mr. Adams moved that we write the Parks Board asking for their assurance that when we have raided sufficient funds for our Community Centre and Ice Rink would they cooperate with us in operating known

Mr. Barnes mentioned several ways of providing money for campaign expenses and advertising..

Mr. Creery, said that the plan should go ahead now. if we are going to do anything and that a good campaign mamager should be contacted,, but that we need the, green or go-ahead signal from this meeting.

Mr. Banfield said If we are going to go ahead something should be done now, but figures will have to be submitted. but lets do it now rather than wit any further.

The Point Grey Community Centre Society held and emergency meeting on Sunday Mar 25th in the Lawn Bowling Club House at 3 P.M.

Those present as per list;
Minutes of last meeting we adopted 2nd Major
Whitley.

Letter s to and from the Parks Board were read, and Mr. Macdonald reported on a special meeting with Mr. Meredity, solicitor for the Donor of the \$75,000.00, and our request to the Parks Board to be allowed to donate \$100,000.00 towards the proposed Rink.

Mr. Banfield stated that we had set out in our own minds the size of a Community Centre which must be self supporting, with sufficient spectator accommodation to provide fees, and the size as set out according to plans of the Donor were not going to be a success, and would be a momument to a man's immature plans, and absolutely inadequate, and a source of dissatisfaction.

Mr. Adams; that in talking to the odd man, felt it would be better to have a small rink for children and that if we refused the \$75,000.00 we might regret it.

Mr. W. Owens. Try and postpone the meeting with the Parks Board and further report to Mr. Meredith to try and cooperate..

Mr. Estey; difficult to turn the proposed project down until Mr. Meredith given a further chance to cooperate

Mr. Fred Trylor, who said he had grown wp with the Donor felt that this 2 or 3 men personally interviewed him would see differently.

Mr. Creery. If the Donor is not prepared to enlarge now, then perhaps at some later date, his (tin pot) rink could be enlarged, but our idea was to develop the whole area, to make it a beauty spot, that he had interviewed the Famous Players in the East and they are putting up the finest Theatre in the West, and are afraid of any inadequate scheme we might put up.
