## AMENDMENT TO THE BY-LAWS:

It was regularly moved by Mr. R. J. Dunn, seconded by Mrs. L. Whiles that By-Law No. 3 be changed to read:

"Membership in this Society shall be divided into three classes, namely: (1) Active, (2) Life, (3) Honorary. Only active and life members shall be considered to be members of the Society within the meaning and operation of the provisions of the Society Act, being Chapter 311 of the Revised Statutes of British Columbia 1948, and be eligible to receive notice of and to vote at any meeting of the Society and to be elected a Director, providing the member is the full age of 21 years."

REPORT OF THE FIGURE SKATING CLUB - presented by Club Fresident Mr. E.F.Ricci. Copy filed.

EEFORT CF THE CENTRE DIRECTOR - a comprehensive booklet prepared by Miss Hamilton was handed to all in attendance. In addition, Miss Hamilton spoke briefly regarding summer programs being offered at the Centre during July and August.

REMARKS BY THE PRESIDENT - Mr. Howden expressed deep appreciation for all the assistance during the year. Among those mentioned were Mrs. Boyce, Mrs. Cousland, Mrs. Franklin and Mrs. Hogg, and also Mrs. Edwards of the Kerrisdale Courier (in absentia). He thanked also Mr. E. T. Orr for his work toward the new Park, construction which is now underway following delay by weather and labour problems. He mentioned also the invaluable help on the Arena Committee given by Mr. G.
